**Candlelyte Policies and Procedures for Independent Associates  
Known as Affiliates, Associates, CandleMakers, CandleMasters**

1. I am of legal age in the state in which I enter this agreement.
2. I shall become a Company Associate upon acceptance of this application by the Company. As an Associate, I shall have the right to use the services and products offered by the Company in manufacturing candles and selling them in accordance with the Company's marketing program and statement of policy, which may be amended and changed from time to time.
3. Upon notification to Associates and Affiliates, the Company, at its discretion, may amend the marketing plan, compensation plan and policies and procedures, etc.
4. I have carefully reviewed the Company's marketing plan, rules and regulations, and policies and procedures, and acknowledge that they are incorporated as part of this agreement in their present form and as modified from time to time by the Company.
5. The term of the Company Associates agreement is one year. Company Associates, who wish to continue their associateship, must apply to renew their Associate agreement annually, including the payment of the annual Business Administration fee of \$29.95.
6. An Associate shall be entitled to cancel participation in the marketing program at any time and for any reason with written notice to the Company. Upon such notification of cancellation or termination, the Company will issue a refund code. The Associate will be able to return, and the Company will re-purchase, any unused inventory of supplies, current sales materials, business kits, product packages which are unopened and in Merchantable condition and so forth at full price paid by the Associate excluding freight, less a 10% restocking fee, for a period of 1 year from the date of supply of such product packages and materials to the Associate. Associate will be responsible for any freight charges incurred in returning any unused materials to the Company.
7. Upon acceptance of this application by the Company, I will be an independent associate responsible for my own business and not an employee of the Company. I will not be treated as an employee in regard to any laws covering employees, including but not limited to public Liability insurance, workers compensation insurance and superannuation, each of which is the Associates responsibility.
8. I will not use the Company's trade name and/or trademark except in the advertising that I have received prior written approval for by the Company.
9. Any Associate, who sponsors other Associates, must fulfil the obligation of performing a bona fide supervisory, manufacturing and selling function in the sale or delivery of product to the end consumer and in the training of those sponsored. Each associate must have ongoing contact, communication and management supervision with his or her sales organisation. Examples of such supervision may include, but are not limited to: newsletters, written correspondence, personal meetings, telephone contact, voice mail, electronic mail, training sessions, accompanying individuals to Company training and sharing genealogy information with those sponsored. Associates should be able to provide evidence to the Company semi-annually of ongoing fulfilment of sponsor responsibilities.
10. The Company's program is built upon the foundation of manufacturing by Associates and retail sales to the ultimate consumer. The Company also recognises that Associates may wish to purchase product in reasonable amounts for their own personal or family use. For this reason, a retail sale for bonus purposes shall include sales to nonparticipants as well as sales to Associates. The Associate will be responsible each month to provide to the company by the 15th of the following month copies of retail sales receipts for a minimum of 70% of all products purchased that month. 30% may be used for personal and family use for which retail receipts are not required. Monthly commissions on your organisation and sales bonuses are contingent upon the Company receiving the above described retail verification in a timely fashion. It is Company policy to strictly prohibit the purchase of product or large quantities of inventory in unreasonable amounts solely for the purpose of qualifying for bonuses or advancement in the marketing program. Associates must fulfil published personal and down-line retail sales requirement, as well as supervisory responsibilities, to qualify for bonuses, overrides or advancements.
11. The Associate acknowledges that Associate is a wholly independent contractor who manufactures candles using the company's products and materials and establishes and services wholesale and retail customers for products manufactured by Associates using Company products and manufacturing supplies. The position of Associate does not constitute either a sale of a franchise or a Distributorship, and absolutely no fees have been or will be required from the Associate for the right to distribute the Company's products and earn commissions (see affiliate agreement form), pursuant to this agreement. This agreement is not intended and shall not be construed to create a relationship of employer-employee, agency, partnership, or joint venture between any Associate, sponsor and/or the Company. As an independent contractor, the Associate shall:
  - A. Abide by any and all federal, state and local laws, rules regulations pertaining to this agreement and/or the acquisition, receipt, holding, manufacturing with, promoting selling, distributing or advertising of Company products or products manufactured by Associate.
  - B. At the Associate's own expense, make, execute or file all such reports and obtain such licenses and insurances as are required by law, public authority or from advice by your independent advisors with respect to this agreement and/or the receipt, holding, manufacturing, selling, distributing or advertising of Company products.
  - C. Be solely responsible for declaration and payment of all local, state and federal taxes as may accrue because of the Associate's activities in connection with this agreement.
  - D. At the Associate's own expense, obtain independent advice regarding setting up associates independent business
12. No purchase or investment is necessary to become a Free Affiliate. Affiliates are entitled to purchase and use the Companies products, but not to participate in the marketing plan or earn commissions.
13. Prior written approval from the Company is required for the following:
  - A. To advertise Company products;
  - B. For there to be more than one Associate in an immediate family, household or business;
  - C. Issuance of an Associate Agreement in a Company and Corporate name or Trust;
  - D. To hold, conduct and/or participate in any "business opportunity meeting" in a public location.
    1. However, the Company, through its recommended marketing procedures, offers training, advice and encouragement for independent Associates to conduct candle making "parties" in their home, where the opportunity and the nature of this business is discussed.
14. The Company may immediately terminate the agreement with an Associate who discredits the Company's name or business, violates any requirement contained in this Agreement, Company Policy and Procedures, or training manuals or misrepresents the Company's products or business opportunity by making claims contrary to the Company's product literature and labels.
  - A. Note: it is expressly prohibited to encourage a person to join, purchase products, or sales aids and literature by quoting what someone else, somewhere, sometime may have earned in this opportunity. You may, of course, discuss your personal experience and, with permission, that of your sponsor.
15. This agreement constitutes the entire agreement between the Associate and Company and no other additional promises, representations, guaranties or agreements of any kind shall be valid unless in writing.
16. This agreement shall be governed by the laws of the State of NSW, and all claims, disputes and other matters between the parties of this agreement shall be brought in the courts of NSW, in Sydney and the Associate irrevocably submits to the jurisdiction of the courts of NSW
17. I acknowledge that I have read and understand and agree to the terms set forth in this agreement.
18. This agreement is not in force until accepted by the Company.
